Golden Whistle Award for the Alberta Soccer Association recognizes outstanding contributions and achievements to the individual who has a long-standing contribution to officiating.

Requirements

To qualify for the award, it is imperative that a nominee satisfactorily fulfills all stipulated requirements:

1. Good Standing: The nominee should be in good standing with the Alberta Soccer Association and its Members, both in terms of their conduct and any administrative requirements.
2. Longevity: 15 years or more of experience and contribution to officiating.

3. Minimum of 10 years of proving contribution to the development of officiating in Alberta

4. Current members of the Referee Development Committee or past members of one year or less are not eligible for nomination

Criteria

Consider the criteria not merely as prerequisites but as a strategic compass, directing nominees towards attributes valued by the Alberta Soccer Association. While meeting every criterion is not obligatory, it significantly amplifies the likelihood of selection.

1. Consistency and Performance: The individual should have consistently demonstrated excellent performance as a soccer referee, maintaining high standards of fairness, impartiality, and game management.

2. Referee Development: The recipient should have contributed to the development of referees within the association, whether through mentoring, coaching, or organizing training programs

3. Consistent Improvement: The individual should have shown a commitment to ongoing improvement by attending training, seminars, and staying up-to-date with rule changes.

4. Leadership and Mentorship: The recipient should have taken on leadership roles within the refereeing community, such as serving as a lead referee, instructor, assessor, assigner, etc. They should have actively mentored and guided new and less experienced referees.
