Camp and Academy Endorsement Guidelines

All programs that are not operated through an Alberta Soccer Regular or Associated Member should familiarize themselves with Alberta Soccer General Rules & Regulations Rule 19, which covers specific rules for non-Member Camps & Academy Endorsement.

CATEGORIES

District or Club Player Development Programs - Operated by District or club. All participants are registered with the specific district or club requesting sanctioning and in Good Standing with Alberta Soccer.

Open Players Development Programs – Operated by a District or Club. Participants can come from any District or Club in the Province. All participants are registered with the Alberta Soccer Association. The program must supply a list of players and will require District signoff.

Private Player Development Programs – Considered for profit programs.

Please note Alberta Soccer will not sanction any camps/academies that conflict with Cavalry FC provincial programming.

NEW AND RENEWAL APPLICATION PROCESS

New Applications and Renewals must be submitted to prai@albertasoccer.com

When preparing an application for endorsement, it is important to include the following elements:

- 1. Administrative Elements:
- List of programs to be offered during the endorsement period.
- Proposed dates and operating hours of the program(s).
- Daily timetable and hours of instruction.
- Off-field activities incorporated into the program.
- Anticipated number of participants.
- Inclusion of a female coach or attendant for co-ed programs.
- Cleared police record checks (within the last three years) for all staff involved, or a letter from the district association confirming they have the checks on file.
- Description of proposed location(s) and facilities to be utilized.
- Emergency action plan and identification of qualified First Aid providers.
- Letter of support from the respective district(s) where the program will operate.

2. Insurance:

- <u>For District or Club Player Development Programs</u>: Coverage for all ASA registered players, coaches, referees, and facilities under the Alberta Soccer Association published policies. Non-ASA registered players must pay appropriate registration fees.
- -For Open Players Development Programs: Coverage for all ASA registered players, coaches, referees, and facilities under the Alberta Soccer Association published policies. Non-ASA registered players must pay appropriate registration fees.
- For Private Player Development Programs: Coverage for ASA registered players, coaches, referees, with written approval from the player's district and club for events outside Alberta. Non-ASA registered players must pay appropriate registration fees. Proof of Commercial General Liability (CGL) insurance with minimum coverage of \$2,000,000 for the registered business operating the camp or academy, with Alberta Soccer added as an additional insured.
- <u>For Education-Based Player Development Programs</u>: Proof of Commercial General Liability (CGL) insurance with minimum coverage of \$2,000,000 for the registered business operating the camp or academy, with Alberta Soccer added as an additional insured
- 3. Technical Elements:
- Compliance with the Long-Term Player Development model.
- Objectives and purpose of the soccer training program.
- Brief synopsis/overview of each program.
- List of coaches and instructors with their coaching certifications, including copies of coaching certificates and/or NCCP numbers.
- Instructor-to-player ratio based on age groups. Minimum requirements are as follows: U4 to U8 8 players to 1 coach, U10 to U14+ 12 players to 1 coach
- Age groups, genders, and skill levels of players.
- 4. Additional Technical Elements (required for Education applications only):
- Noting NCCP coaching qualifications for all instructors.
- Strong recommendation of a certified teacher supervising the training sessions.
- Recommended hours of instruction for different school levels.
- Inclusion of sport performance, player, and coach education programs in the soccer curriculum.
