## COVERAGE

### 1. Out of Province Medical Limit \$25,000

Excess Medical coverage for when travelling outside of Alberta. The event has to be approved and sanctioned by the Alberta Soccer Association and who's name is registered with the association prior to traveling. Coverage is in excess of any Provincial Health Care:

- Surgical Reattachment - Various limits based on specific loss benefit
- Repatriation - maximum \$15,000
- Identification - maximum \$45,000
- Rehabilitation - maximum \$15,000
- Rehabilitative Physical Therapy - maximum \$15,000
- Funeral - maximum \$5,000
- Bereavement - maximum \$1,000 (limited to 6 sessions)
- Spousal Retraining - maximum \$15,000
- Dependant Child Educational Benefit maximum of \$5,000 per year
- Day Care - 5% of Benefit Amount to maximum of \$5,000 per year
- Family Transportation - maximum \$15,000

- Home Alteration & Vehicle Modification - maximum - \$15,000
- Seat Belt and Airbags - up to \$50,000 maximum
- Parental care - 10% of benefit amount to a maximum of \$10,000
- Aggregate limit: \$500,000 for any one known accumulation and \$500,000 per anyone Aircraft accumulation.
