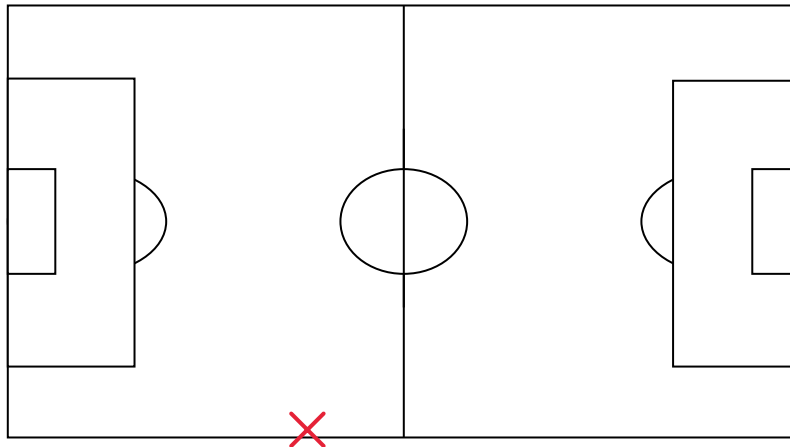
The incident occurred 12 minutes into the game and was as follows:

During play in the 12th minute, #3 John Smith of the Jets made shoulder to shoulder contact with an opposing player, forcing them to make contact with the boards in a dangerous manner. I stopped play and showed #3 John Smith of the Jets a red card (send-off) for boarding. #3 John Smith of the Jets initially questioned the call while repeatedly saying I was a "stupid idiot." I calmly asked #3 John Smith from the Jets to leave the field of play, which he eventually did. Play was restarted with a direct free kick to the bombers for the original boarding offence.

#3 John Smith of the Jets returned at the end of the game after the final buzzer and waited by the gate. As my crew left the field, #3 John Smith apologized for his actions and then left the vicinity without further incident.
